The international PhD programme in Criminology combines training, research and teaching. The training programme is established by the Board of teachers according to the characteristics of each candidate: PhD students with a scholarship will be engaged in full-time activities also at one of the affiliated locations; PhD students without a scholarship will be engaged in training and research activities on a periodic basis.

Eligible candidates are undergraduates who obtain their degree, in Italy or abroad, by 30 November 2022.

The PhD programme is entirely in English with the possibility of the recognition of the *Doctor Europæus* label and the writing of co-authored theses. During the three-year period it is possible to spend a research period abroad in international organisations and/or at European universities and research centres.

In addition to the application form, each candidate must enclose:

- a detailed *CV* in English;
- a research project in English. The project should briefly state the state of the art, the research problem and questions, the objectives and methodology, the expected results and possible limitations of the research and bibliographical references. The entire document must not exceed 20,000 characters (including spaces);
- at least two letters of reference. These letters must be sent directly by the teachers to the e-mail address (transcrime@unicatt.it) no later than the deadline of this notice;
- for university graduates, self-certification of the degree held, with final grade and list of examinations taken with the relevant marks, or certification of the degree obtained at a foreign university, with final grade and list of examinations taken with the relevant marks;
- for undergraduates, self-certification of enrolment in a degree programme with the list of examinations taken and the relevant grades, or in a foreign academic programme with the list of examinations taken and the relevant grades;
- certification of any further qualifications such as specialising master degrees and post-graduate degrees obtained in Italy or abroad, with a list of examinations taken and the relative marks and a copy of any other qualification considered useful for evaluation purposes;
- publications deemed useful for the evaluation.

Evaluation Procedure

Assessment for admission to the PhD programme is based on the following elements:

- curriculum vitae* and other qualifications;
- research project;
- interview with at least one member of the Selection Committee.



The evaluation is based on a scale of 0 to 70 points awarded according to the following criteria:

- Items (a) and (b) are each rated from 0 to 20 points. Only candidates scoring a total of 30 points are admitted to the interview. The results of the assessment of elements (a) and (b) are communicated to the applicant by *e-mail* together with the invitation to the interview, if any. These results will also be visible at <http://milano.unicatt.it/dottorati-risultati>;
- item (c) is rated from 0 to 30 points. The interview, in English, is aimed at discussing the candidate's motivation and project and answering the examining board's questions. Only candidates who score at least 20 points in the interview can be admitted to the PhD programme.

The final ranking results from the sum of the scores obtained in criteria a), b) and c).

Candidates are admitted to the PhD programme in the order of the ranking list, according to the number of places available.

Scholarship

In recognition of each month of collaboration in the activities of Centro Transcrime, PhD students enrolled in the first year may receive an additional amount up to a maximum of approx. € 2,500.00 (gross figure) per year. Those enrolled in the second and third year may receive an additional amount up to a maximum of approx. € 4,600.00 (gross figure) per year.

The additional remuneration will be recalculated in the event that the basic amount of the scholarship set by law is updated.

The 50% increase of the scholarship for research activities abroad, provided for each scholarship holder, will in any case be calculated on the base amount established by law.

Financial support for competition winners living abroad

In order to promote the internationalisation of the PhD programme, successful candidates with a Graduate degree or equivalent degree from a foreign university may receive up to € 5,000.00 for documented travel and accommodation expenses incurred in moving to Milan during the first year of the PhD programme.

The PhD programme in Business, Labour, Institutions and Criminal Justice responds to a scientific and educational project that intersects the areas of business law, comparative labour and social security law, international law, criminal law and public law. The course is intended for young scholars who demonstrate an aptitude for scientific research.

In addition to the general pathway relating to the above-mentioned areas, the PhD includes a targeted research pathway in the field of criminal law and criminology, as well as a targeted research pathway in the field of active labour and income support policies, implemented through advanced technology, including *blockchain* and distributed registers.

During the first year, the doctoral student may be required to participate in training activities up to a maximum of 100 actual hours.

Admission to the PhD programme requires a graduate degree in law or economics or social sciences (corresponding to the following classes: LMG1 (Law), LM56 (Economics), LM62 (Political Science), LM63 (Public Administration Science), LM77 (Economics and Business Studies)) with a minimum mark of 105/110 or an equivalent qualification obtained abroad.

Graduating candidates in the same degree classes who have achieved an average of at least 28/30 in their exams and will graduate by 31 October 2022 may also be admitted.

Admission to the PhD programme is incompatible with enrolment and/or participation in the Post-graduate School for the Legal Professions.

All candidates are required to have an adequate knowledge of Italian and of another language; if the second language is other than English, the candidate must in any case demonstrate a sufficient knowledge of English.

Application for Participation

In the application, applicants must declare:

- to compete for a place on the general list, possibly specifying their intention to compete only for a place without a scholarship;
- to compete for places aimed at interdisciplinary research in criminal law and criminology, with a scholarship co-financed by Alta Scuola “Federico Stella” sulla Giustizia Penale;
- to apply for the place aimed at research in the field of active labour and income support policies implemented through advanced technology, including *blockchain* and distributed registers, financed by Fondazione Giacomo Brodolini;
- to compete for the post aimed at research consistent with the areas of relevance identified by Ministerial Decree 351/2022, as defined in Annex A to this notice.



Candidates competing for the places aimed at interdisciplinary research in criminal law and criminology and for the place aimed at research consistent with the areas of relevance identified by Ministerial Decree 351/2022, also compete for places on the general classification list if they are successful in the tests and do not qualify for the scholarship co-financed by Alta Scuola "Federico Stella" sulla Giustizia Penale or the scholarship for research consistent with the areas of relevance identified by Ministerial Decree 351/2022.

Attachments to the application

In their application candidates may enclose a research topic with an outline of the subject, hypotheses and methodology considered most appropriate for carrying out the research.

All applicants may attach an electronic version of:

- a copy of any other qualification considered useful for the purposes of evaluation, with a list thereof;
- a copy of their dissertation and publications deemed useful for the evaluation, with a list thereof;
- a copy of one of the following certifications of English language proficiency (which, in any case, is not a substitute for an English language proficiency test) BEC, British Chamber of Commerce, CAE, CPE, FCE, IELTS, TOEFL, Trinity College London Certificate.

Entrance Examination

On the proposal of the Board of teachers, the Rector appoints:

- a General Selection Board, for the allocation of places on the general list and of scholarship places for interdisciplinary research in the field of criminal law and criminology, consisting of five tenured professors in the disciplinary scientific sectors to which the PhD programme relates (at least one of whom belongs to the disciplinary scientific sector IUS/17);
- a Special Selection Board, for the assignment of the place with scholarship for research in the field of active labour and income support policies implemented through advanced technology, including *blockchain* and distributed registers, composed of three tenured Labour Law professors.

The entrance examination consists of:

- 1) in an evaluation of the *curriculum vitae* and qualifications submitted by the candidate;
- 2) in a written test;
- 3) in an oral test.

In relation to the assessed qualities and achievements, each candidate is awarded up to 60 points for each of the three parts of the entrance examination, for a maximum total score of 180 points.

Any candidate who has obtained a score of not less than 40/60 in the assessment of *curriculum* and qualifications is admitted to the written test.

Any candidate who has obtained a mark of not less than 40/60 in both the assessment of the *curriculum* and qualifications and the written test shall be admitted to the oral test.

The oral test is passed if the candidate obtains a mark of no less than 40/60 and demonstrates an adequate knowledge of a foreign language and, if the second language is other than English, an adequate knowledge of English.

Conduct of examinations

The written and oral examinations will be conducted in Italian and will consist of a test of the candidate's knowledge of topics of interest to the PhD programme and its research



profiles, as well as their propensity for scientific research. Candidates competing for places with scholarship aimed at interdisciplinary research in the fields of criminal law and criminology or in the field of active labour and income support policies implemented by means of advanced technology will have to sit the written test relating to the criminal law or labour law and industrial relations field of study, in accordance with the indications given in the application.

The oral test will be followed by a test of knowledge of a foreign language. If the second language is other than English, the candidate must in any case demonstrate sufficient knowledge of English. The oral test may also relate to the research topic that the applicant may have attached to the application.

In order to take the tests, candidates must present a suitable valid identification document pursuant to Article 35, second paragraph of Presidential Decree No. 445 of 28 December 2000 (identity card, driving licence, passport).

Rankings

The Selection Board for the assignment of places on the general list and for the assignment of scholarships aimed at interdisciplinary research in the fields of criminal law and criminology, as well as the performance of research consistent with the areas of relevance identified by Ministerial Decree 351/2022, evaluates the *curriculum vitae*, qualifications and tests, and assigns the scores for candidates competing for the allocation of places with non-focused scholarships, places without a scholarship and places with scholarship aimed at interdisciplinary research in the fields of criminal law and criminology and the performance of research consistent with the areas of relevance identified by Ministerial Decree 351/2022.

The Special Selection Board for the awarding of the scholarship for research in the field of active labour and income support policies, implemented by means of advanced technology, evaluates the *curriculum vitae*, qualifications and evidence and awards marks for the candidates competing for the above-mentioned scholarship.

On the basis of the marks awarded, the Selection Boards will form two merit lists:

- an overall ranking of the candidates for the places with non-focused scholarship, the places without scholarship, the places with scholarship aimed at interdisciplinary research in the fields of criminal law and criminology, and the place with scholarship aimed at carrying out research consistent with the areas of relevance identified by Ministerial Decree 351/2022;
- a special ranking of only those candidates competing for the scholarship for research in the field of active labour and income support policies implemented through advanced technology.

The place with scholarship for research in the field of active labour and income support policies, implemented by means of advanced technology, is awarded on the basis of the special ranking list.

The two places with scholarship for interdisciplinary research in the fields of criminal law and criminology shall be awarded to the first two candidates who, having indicated that they are applying for these places at the time of their application, have taken the written test in the field of criminal law and have been successful in the oral test, and were placed in the general classification list. Should these candidates be placed in the general classification list in a position for which an untargeted scholarship or a place without scholarship is to be awarded, the classification list will be surveyed for the purposes of awarding this scholarship or this place without scholarship.

The place with scholarship for the purpose of carrying out research consistent with the areas of relevance identified by Ministerial Decree 351/2022 shall be assigned to the first



candidate who, having indicated that they are applying for this place at the time of application, have taken the written test in the subject relevant to the finalised project defined in Annex A to this notice and have passed the oral test, and were placed in the general classification list. Should this candidate be placed in the general classification list in a position for which an untargeted scholarship or a place without scholarship is to be awarded, the classification list will be surveyed for the purposes of awarding this scholarship or this place without scholarship.

Candidates wishing to apply for a reserved PhD place pursuant to Ministerial Decree 351/22 must necessarily indicate this in their application and submit a research project consistent with the title of the project for the place. The place reserved for a PhD programme pursuant to Ministerial Decree 351/22 may not be assigned to candidates who have not competed for the specific place.

For the PhD place pursuant to Ministerial Decree 351/22, consideration will be given to projects with a historical-institutional perspective aimed at promoting the following research topics: origin and development of the administrative organisation responsible for planning and implementing public environmental policies in Italy (ministries, public bodies and national, regional and local agencies); historical-comparative analysis of the administrative organisation and management of environmental policies in federal or strongly regionalist contexts of the European Union and the Euro-Atlantic area, in order to highlight the specific features of the Italian system and to identify possible new regulatory and organisational solutions at national and supranational level. In addition to a fundamental historical knowledge base, the candidate is also required to have the ability to navigate across several scientific-disciplinary fields. In view of the comparative-historical nature of the project, a mastery of the English language and, preferably, a good knowledge of at least a second European language among German, French and Spanish is also required.

The entrance examination, which is designed to ascertain the candidate's preparation, skills and aptitude for scientific research, consists of:

- in an evaluation of the qualifications and research project submitted;



- in an oral test.

In relation to the qualifications, the Board may award each candidate a score of up to a maximum of 30/100.

For the purposes of assessing the qualifications, in the application each candidate must enclose, under penalty of exclusion:

- their *curriculum vitae*;
- the list of examinations taken in the undergraduate and graduate degree programmes, with the corresponding marks (also as self-certified);
- the table of contents, introduction, conclusions and bibliography of their graduate dissertation.

Any other qualifications, such as publications, certifications of language skills or other documentation proving professional and research experience relevant to the application may also be attached.

Applicants are required to provide in support of their application the names of two tenured university professors acting as *referees* (indicating their position, *e-mail address*, telephone number), whom the Board is entitled to contact.

With regard to the research project, which candidates must enclose in their application, the Board may award each candidate a score of up to 40/100.

The research project must be no longer than 2,000 words (excluding bibliography).

Candidates who obtain a total score of not less than 55/100 in the evaluation of their qualifications and research project are admitted to the oral test.

In relation to the oral test, the Board may award each candidate a mark up to a maximum of 30/100.

The oral test will include a discussion of the titles and research project presented by the candidate; it will also include a test of knowledge of the first foreign language indicated by the candidate.

The oral test is only passed if the candidate scores no less than 20/100 and demonstrates an adequate knowledge of a foreign language.

The candidate may choose to take the entire competition test in Italian or in English. In the latter case, the Board will subject the candidate to a test to verify their sufficient level of Italian.

In order to take the oral test, candidates must present a suitable valid identification document pursuant to Article 35, second paragraph of Presidential Decree No. 445 of 28 December 2000 (identity card, driving licence, passport).

The multidisciplinary PhD programme focuses on the specific *social work* competences included in the scientific-disciplinary sector SPS/07. - the quality of the dissertation (consistency of the theme of the dissertation with the PhD programme and with the place for which the candidate is applying; relevance and originality of the theme, presence or absence of an empirical research part; articulation of contents, structure of the text and effectiveness of written expression; relevance, breadth and international references of bibliography) and of any publications (scientific level, editorial placement, consistency with the PhD programme);
- any professional experience (consistency with the PhD programme and the place for which the candidate is applying, originality or innovativeness);
- any research experience, other than empirical or theoretical research carried out for the dissertation (consistency with the PhD programme and the place for which the candidate is applying, scientific level).

Written test

The written test will consist in writing a paper (in Italian or English) on the basis of a title chosen by the candidate from among those provided by the Board. One of three envelopes prepared by the Board will be drawn by one of the candidates present. The envelope will contain three titles, from which each candidate may choose the title to discuss in their paper. The time available will be two hours and, where organisational conditions allow, the drafting will be carried out on a PC provided by the university, using the Word editor. Alternatively, traditional handwriting will be used.

Titles will cover conceptual categories fundamental to Social Work and Personal Social Services Policies, with relevant sociological, psychological and legal references. Candidates will be invited to complete the paper by developing the proposed topic in the way that best suits their preparation, from a perspective that may focus more on Social Work or Personal Social Services Policies, as they choose.

Oral test

The oral test (in Italian or in English) will be a test of the candidates' knowledge of social work, sociology and social policy based on the contents of their paper. An orientation interview will also be held to understand the candidates' interests and perspectives and finally, a test of knowledge of English mastery (or Italian, if the interview is held in English) will be carried out through the translation of a short piece of specialist literature. In order to sit the written test and the oral test, candidates must present a suitable valid identification document pursuant to Article 35, second paragraph of Presidential Decree 445 of 28 December 2000 (identity card, driving licence, passport).

Scoring

The Selection Board awards each candidate the following marks:

- evaluation of qualifications: up to 30 points;
- evaluation of the written test: up to 30 points
- oral test: up to 40 points.

Any candidate who has obtained a score of not less than 21/30 in the assessment of qualifications shall be admitted to the written test.

Any candidate who has obtained a mark of not less than 21/30 in the written test assessment shall be admitted to the oral test.

The oral test is deemed to have been passed if the candidate has obtained a score of not less than 28/40.

At the end of the examination tests, the Selection Board draws up the merit lists, one for each place, on the basis of the marks obtained by the candidates.

The PhD programme in Sociology, Organisations, Cultures was created by building on a long and rich experience gained in the PhD programmes “Sociology and Methodology of Social Research” and “Organisational and Managerial Sciences”. In particular, it integrates the theoretical-methodological knowledge of sociology with managerial and organisational knowledge, succeeding in combining advanced training for academic recruitment with advanced training for companies and organisations in the remaining labour market.

The PhD programme has a teaching board made up of scholars from various disciplinary fields (general theory and sociology, sociology of work and organisations, sociology of culture and communication, sociology of *welfare*, development of innovative social research methodologies, etc.), most of whom belong to the Sociology Department of Università Cattolica and are part of important national and international research networks, as well as working in the professions. Candidates admitted to the PhD programme will therefore have the opportunity to carry out research and write a



dissertation in one of the many fields for which they will find support among the lecturers of the college.

Evaluation Procedure

When responding to this call for applications, candidates must attach a research project of max. 10,000 characters (including spaces and bibliographical references) divided into the following sections: subject, brief state of the art, research question, methods that would be adopted to answer the question. The project written by the candidates will not be binding with respect to the actual research to be developed during the PhD.

The entry examination, which is designed to ascertain the candidate's preparation, skills and aptitude for scientific research, consists of:

Art. 8

Contributions and scholarships

Contributions required for access to and attendance at doctoral programmes at Università Cattolica is determined annually by the Board of Directors.

PhD students enrolled in the 38th cycle are required to pay annual contributions for access to Doctoral programmes for an amount of € 1.516,00 to be paid in no. 3 instalments, the first upon enrolment (€ 516,00), the second before the 28th of February (€ 500,00) and the third by the 30th June each year (€ 500,00).

According to the Italian Law, a scholarship to attend the PhD Programme is compatible with other income earned, also on a regular basis, in the calendar year of the scholarship, provided that such income does not exceed the amount of the scholarship itself. Should these income limits be surpassed, the scholarship shall be revoked for the year in question. For the verification of the income limits, scholarship assignees shall annually declare the income earned and notify exceeding of the prescribed limit.

The scholarships are annual and are renewed on condition that the PhD student has completed the program of the activities planned for the previous year.



The amount of the scholarship, paid in monthly instalments, is € 16,243.00 per year, before social security charges. The scholarship is subject to the payment of social security contributions (in Italy INPS) separately managed in accordance with Article 2, paragraph 26, of Law no. 335 of August 8th, 1995, as amended. The scholarship is exempt from the payment of local personal income and income tax (IRPEF).

This amount shall be increased by a maximum of 50% for a total period not exceeding 12 months, if the PhD student is authorized by the Teaching Panel to carry out research activities abroad.

From the first year, each PhD student, with and without a scholarship, is insured for research activities in Italy and abroad for a budget of 10% of the gross annual amount of the scholarship, equal to € 1,624.30.

Those who have previously, even partially for another PhD course, benefited from it may not be eligible for a doctorate scholarship.

Art. 9

PA employee

Current legislation on leave of absence or special leave applies to public employees admitted to the PhD Programme.

Art. 10

Rights and duties of doctoral students

PhD students are required to regularly participate in the activities set out in their curricula, and to commit to individual and guided study programmes and to carrying out the research activities assigned by the Teaching Panel.

PhD students are also required to consult the Code of Conduct of Università Cattolica and to comply with its principles and aims.
